

- October 2019: Assisted in scheduling and convening a HCA-led Mobile Crisis Response(MCR) Facilitated Community Discussion with regional stakeholders.



## Mobile Crisis Response (MCR)

As part of the TSA Phase I, the HCA is enhancing the capacity for mobile crisis response in the Spokane region by:

- Requiring plans from the region on how they provide mobile crisis services tailored to the region's community needs.
- Contracting with the SCRBH (ASO) to enhance the capacity of MCR services in the region with the goal to hire MCR staff and begin services by July 1, 2020.
- Creating awareness of MCR services and how to request them through outreach and education.





### **Crisis Services**

- Crisis means a behavioral heal crisis, defined as a turning point, or a time, a stage, or an even, whose outcome includes a distinct possibility of undesirable outcome.
- Crisis Services (Behavioral Health) – means providing evaluation and shortterm treatment and other services to individuals with an emergent mental health condition or are intoxicated or incapacitated due to substance use and when there is an immediate threat to the individual's health or safety.

Crisis Services in the Region Include: Mobile crisis response services with the ability to respond to a behavioral health crisis in the community (e.g., homes, schools, or hospital emergency rooms).

Involuntary Treatment Act (ITA) services in accordance with RCW 71.05 and RCW 71.34. Crisis services become ITA services when a Designated Crisis Responder (DCR) determines an individual must be evaluated for involuntary behavioral health treatment.

A range of short-term crisis stabilization services (e.g., lesser restrictive alternative in the community with natural supports to assist in implementing a safety plan).

# Crisis Services in the Region Include:

Urgent and Emergent care services with the capacity for immediate clinical intervention, triage, and stabilization (e.g., Crisis Stabilization facilities, Evaluation and Treatment centers, Secure Withdrawal Management and Stabilization Services facilities, inpatient psychiatric admissions, single bed certification placement).




### Crisis Services Eligibility

All individuals in the region, regardless of insurance status, ability to pay, county of residence, or level of income, are eligible to receive medically necessary:

- Mental Health Crisis Services,
- Substance Use Disorder (SUD) Crisis Services, and
- Services related to the administration of the Involuntary Treatment Act (ITA) and Involuntary Commitment Act (Chapters 71.05 and 71.34 RCW).



Enhancement of Mobile Crisis Response Services (MCR)



Funds for FBH will provide a dedicated team consisting of 1 Supervisor, Masters level clinician, 2 Bachelor's level clinicians, 1 SUDP, and .75 Peer Counselor.

FBH will provide support services to Pend Oreille County Counseling Services and North East Washington Alliance Counseling Services.
