

Macluumaadka Kaalmada Xisaabta Canshuurta Cunugga

Canshuurta Xisaabta Cunugga (Child Tax Credit) (CTC) ma aha xisaab cusub balse waxaa la baddalay 2021 - lacag badan ayaa la heli karaa iyo 90% kuwa xaq u yeesha waxaa toos loo hormarin kara lacagaha.

Xaq u Yeelashada CTC

- Haddii da'da cunugaada/caruurtaada u dhexeyso 0 ilaa 17 sanno (Si ay u qaataan, caruurta waa in ay leeyahiin nambarka Soshal Sekuritiga)
 - \$3,600 halkii cunug ay da'diisu u dhexeyso 0–5 sanno
 - \$3,000 halkii cunug ay da'diisu u dhexeyso 6–17 sanno
- Si aad u qaadatid Canshuurta Xisaabta Cunugga (CTC) oo buuxda, canshuur bixiyeyaasha ma soo geli karto in ka badan:
 - \$150,000 xagga canshuur bixiyeyaasha guursaday iyo ninka/naagta laga dhinta ee si wadajir ah u soo gudbiya canshuur celinta
 - \$112,500 xagga madaxa reerka
 - \$75,000 xagga dhamaan canshuur bixiyeyaasha
 - Kaddib marka xisaabta ka koreyso xisaabta canshuurta cunugga soo yaraato

Hormarinta lacagaha waxaa la bilaabi doonaa Luulyo

IRS waxay ku hawlan tahay in ay horay u bixiso kala bar xisaabta kore laga bilaabo Luulyo 15, 2021.

Waxaad qaadan doontaa \$300 halkii bil halkii cunug oo xaq u yeesha iyo ku tiirsan oo jira 0-5 sanno (\$1,800 haddii uu ka weyn yahay 6 bil) ama \$250 halkii bil xagga cunug kasta oo xaq u yeesha iyo ku tiirsane jira 6-17 sanno (\$1,500 haddii uu ka weyn yahay 6 bil). Waxaad heli doontaa baaqiga lacagta marka ay soo gudbiyaan canshuurta sannadka 2022.

Sidee looga baxaa lacagta la bixiyo bil kasta

Waxaad toos u heli doontaa xisaabta canshuurta cunugga bil ilaa bil haddii aad soo gudbisay canshuur celinta 2019 ama 2020, aadna sheegatay Canshuurta Xisaabta Cunugga ama aad IRS siisay macluumaadkooda adiga oo isticmaala barnaamijka Kuwa Aan-Soo Gudbinin (Non-Filers Tool) ee laga helo IRS.gov si aad u qaadatid lacagaha kixinta (stimulus payments). Haddii aad dooneysid in aad ka baxdid in aad qaadatid lacagta la bixiyo bil kasta ama in aad casriyeysid tirada caruurta adiga kugu tiirsan, waxaad isticmaali kartaa Xariirka IRS (IRS Portal) si aad u casriyeysid macluumaadkooda.

Weli ma aadan soo gudbinin canshuurta 2020 ama lagaama rabo in aad soo gudbisid canshuurta 2021

Toos ma u qaadan doontid bil ilaa bil xisaabta canshuurta cunugga (CTC) haddii...

- Aadan soo gudbinin canshuurta 2020, aan lagaa rabin in aad soo gudbisid canshuurta 2021, iyo ma aadan siinin IRS macluumaadkaada adigoo adeegsada barnaamijka Kicinta Kuwa Aan-Soo Gudbinin (Stimulus Non-Filers Tool).
- Waxaad u baahan doontaa in aad isticmaashid Barnaamijka Kuwa Aan Soo Gudbinin Canshuurta (Non-Filers Tool) ee cusub
- Ma u baahnid in aad samaysid sidaan haddii aad qaadatay jeegagga kicinta (stimulus checks). Haddii aad qaadatay jeegagga kicinta balse aad u baahan tahay in aad casriyeysid macluumaadkaada, waa in aad isticmaashid xariirka CTC IRS (<https://www.irs.gov/credits-deductions/child-tax-credit-update-portal>).

Child Tax Credit Helpful Information

The Child Tax Credit (CTC) is not a new tax credit but it has changed for 2021—more money is available and 90% of those eligible will automatically receive advance payments.

Eligibility for the CTC

- If your child/children are between the ages of 0 to 17 (Children must have a Social Security number to be eligible)
 - \$3,600 per child ages 0–5
 - \$3,000 per child ages 6–17
- To receive the full CTC taxpayers cannot make more than:
 - \$150,000 for married taxpayers filing a joint return and qualifying widows/widowers
 - \$112,500 for heads of household
 - \$75,000 for all other taxpayers
 - After the amounts above the credit gets progressively smaller

Advanced payments start in July

The IRS is releasing half of the amounts above in advance starting on July 15, 2021.

You will receive \$300 per month for each qualifying child and dependent age 0-5 (\$1,800 over 6 months) or \$250 per month for each qualifying child and dependent age 6-17 (\$1,500 over 6 months). You will get the rest of the money when they file taxes in 2022.

How to opt-out of monthly payments

You will automatically get the CTC in monthly payments if you filed a 2019 or 2020 tax return and claimed the Child Tax Credit on the return or gave the IRS their information through the Non-Filers Tool on IRS.gov to receive the stimulus payments.

If you want to opt-out of receiving the payment monthly or update the number of children you have as dependents, you can use the IRS Portal to update their information.

Not yet filed your 2020 taxes or you are not required to file 2021 taxes

You will not automatically get the CTC in monthly payments if...

- You did not file taxes in 2020, were not required to file taxes in 2021, and did not give the IRS your information through the Stimulus Non-Filers Tool.
- You will need to use the [new Non-Filers Tool](#)
- You do not need to do this if you received any of the stimulus checks. If you received stimulus checks but need to update your information you should use the CTC IRS portal <https://www.irs.gov/credits-deductions/child-tax-credit-update-portal>
