### Elevator Pitch

- The Spokane Collaborative is a convening for community and health partners in Spokane County
- The Collaborative is a space to connect to other organizations, build relationships, and hear about what's going on in the community to impact health.
- Our mission is to address health equity in our community through cross-sector work and partnership building.
- New members are welcome anytime. Our members have built over 100 connections to other organizations since 2020!
- We are convening workgroups to impact four equity priority areas:
  - Affordable Housing
  - Reducing Family Violence & Trauma
  - Access to Behavioral Health
  - Oral Health

The Affordable Housing workgroup of the Spokane Collaborative is working to improve availability of rental assistance, access to pre-requisite curriculum for affordable housing, and transportation from affordable housing to health services.**

## Suggested answer to conversation prompts for potential new members

- 1. How did you (outreach person) get involved in the Collaborative? What parts have been most valuable to you?**
  - Up to the you to answer this one 😊
- 2. What the CCT (Collaborative Connection Team – leadership body) do?**
  - The CCT is the leadership group for the Collaborative. They guide the strategic direction of the Collaborative, make budget decisions and release funding opportunities, look for opportunities for the Collaborative, and more.
  - When the CCT makes budget decisions, it is typically to allocate a pot of funds for the Collaborative as a whole or as workgroups to make specific decisions about. We're fans of participatory budgeting practices.
- 3. What does a typical Collaborative monthly meeting look like?**
  - The Collaborative meetings monthly on the 3<sup>rd</sup> Thursdays, 1-3pm.
  - Typically, the full Collaborative meets 1-2pm, and then the equity workgroups breakout from 2-3pm.
  - At each meeting we have time for showcasing Collaborative partners and brief share-outs of partner news, asks, and upcoming events.
  - We may also do other things as the full group, like planning or sharing out from equity workgroups, connection-building events like speed dating, and visioning/ planning/direction setting for the Collaborative.
- 4. What does an equity workgroup meeting look like or cover?**

- Each workgroup is at a different place in their planning and implementation process. So each workgroup is self-governed and paced.
- A workgroup meeting may include planning next steps, check-in and course correction, making budget decisions, brainstorming direction, identifying partners to support work, learning and sharing about existing efforts to boost, and more.

### **5. How do I get involved in an equity workgroup activity?**

- Getting involved in a workgroup is as easy as starting to attend the workgroup meetings. When you see work you would like to support or lead, discuss it with the group. The workgroups are self-governing, and welcome new members and ideas.
- For information about what the workgroups are current working on, ask your mentor and see this [page](#).

### **6. How many representatives from each organization join the meetings?**

- Organizations can bring as many representatives as they like!
- Some organizations participate in multiple equity workgroups, which meet simultaneously during the monthly Collaborative meeting, so it's helpful to have more than one representative in that case.
- Note that there is still only one vote per organization on voting matters (such as approving the Charter, budgets, etc.)

### **7. Are we expected to meet outside of the monthly Collaborative meeting?**

- No. The exception is workgroup activity leads, who may meet separately with BHT between Collaborative meetings as needed.

### **8. Is there compensation for joining the Collaborative meetings?**

- No, but there is no membership fee either!
- Collaborative members with an active MOU are eligible to request Collaborative funds through the workgroup activities and LOIs/RFPs as available.

### **9. I would like to share work my organization is doing / a project I need partners for. Who do I ask to present at the Collaborative?**

- Great! There is time on the agenda at every monthly meeting for Partner Shares. You can notify the BHT staff in advance, particularly if you have materials you'd like to share.
- We also do more in-depth Partner Showcases at most meetings. These may be themed around particular sectors, interesting local partnerships, or showcasing new Collaborative members.
- BHT also helps connect Collaborative members following meetings using our [Coffee Date Request](#), if members would like a warm introduction to each other.

4. What is your favorite project you're working on? What is the least favorite?
5. Is there a project or idea you are stuck on that could get off the ground with some support/partnership?

- At each meeting we have time for showcasing Collaborative partners and brief share-outs of partner news, asks, and upcoming events.
- We may also do other things as the full group, like planning or sharing out from equity workgroups, connection-building events like speed dating, and visioning/planning/direction setting for the Collaborative.
